# Refresh of the NZSL Strategy: Cabinet paper for feedback

#### **Purpose**

This briefing seeks your feedback on a draft Cabinet paper, seeking approval for the New Zealand Sign Language Board (the Board) to consult on the draft New Zealand Sign Language (NZSL) Strategy.

Providing your feedback by 17 February will enable your feedback to be incorporated into the version sent to you on 18 February for Ministerial consultation.

## Refresh of the NZSL Strategy: Cabinet paper for feedback

#### **Background**

- The current NZSL strategy expired at the end of 2023. The Board has been working to refresh the NZSL Strategy, <sup>\$9(2)(f)(iv)</sup>
- We recently provided you with the draft Strategy for your feedback (see REP/WHK/25/1/001]. We now provide you with a draft Cabinet paper that seeks approval for the Board to consult on the draft NZSL Strategy.

### The Cabinet paper also seeks to rescind amendments to the NZSL Act proposed by the previous government

- The Cabinet paper also seeks to formally rescind proposed amendments to the NZSL Act, that were proposed by the previous government. These changes intended to turn the Board into a statutory Ministerial advisory group, and to formally include the Board's functions in the Act.
- However, the Amendment Bill had not been introduced prior to the election, and in January 2024, the previous Minister for Disability Issues, Hon Penny Simmonds, decided not to progress with these amendments [see Ministry of Social Development report, REP/23/12/927].
- As part of the transfer of the administrative responsibility for the NZSL Act to Whaikaha, MSD advised that the formal step of rescinding the relevant Cabinet decisions had not occurred. This Cabinet paper therefore seeks to take this step by rescinding the relevant Cabinet minute [SWC-23-MIN-0022].
- Officials continue to look for ways to improve the operation and profile of the NZSL Board. This includes additional governance training for the Board, establishing a Turi Māori advisory group to support the Board with Turi Māori expertise, and work around the strategy consultation process.

#### Next steps

- We are currently consulting government agencies on the draft NZSL Strategy and Cabinet paper and will provide you with an updated version of the documents for Ministerial Consultation on 18 February 2025.
- Providing your feedback by 17 February will enable us to incorporate your changes into the Cabinet paper prior to us providing you with an updated version for Ministerial consultation.
